### Fiscal Note

This proposed resolution authorizes the double fill of position #3776 at CG44-RG12 during the anticipated date range of January 2, 2017 through March 31, 2017 at an estimated cost of \$22,127 for salaries and benefits. This cost will be absorbed in Metro's 2017 operating budget and managed through salary savings.

### Title

Resolution authorizing a double-fill of position #3776 Transit Information Systems Coordinator due to the retirement of David Eveland.

### Body

WHEREAS, Transit Information Systems Coordinator David Eveland is retiring from City of Madison employment effective March 31, 2017; and

WHEREAS, this position is critical to the smooth operations of Madison Metro as it is a key IT project management position, and

WHEREAS, Madison Metro has requested the authorization to double-fill the position held by Mr. Eveland in order to ensure an orderly transition, and

WHEREAS, Madison Metro intends to recruit to fill the position on or about January 2, 2017 in order to allow the selected candidate time to work with Mr. Eveland to learn the position, and

WHEREAS, the double-fill will exceed thirty (30) days;

NOW, THEREFORE BE IT RESOLVED, that Madison Metro is authorized to double-fill the position of Transit Information Systems Coordinator from January 2, 2017 through March 31, 2017, or Mr. Eveland's final date on the payroll, whichever is later.
