### Fiscal Note

In the adopted 2016 Capital Budget Engineering - Bike/Ped has budgeted \$680,000 for the resurfacing of existing bike paths with deficient pavement ratings via the Bikeways Program (MUNIS 10138). The minor project for the bike and pedestrian path from Powers Avenue to Highway 30 is budgeted with sufficient authority for the proposed cost of the work (MUNIS10160). Funding is provided by GO Borrowing.

The resolution approves plan documents at a total estimated cost of \$640,000.
