In the adopted 2017 Capital Budget the Parks Division has budgeted \$1.29M for improvements to Madison's Community, Neighborhood, and Mini Parks under the Park Land Improvements program (MUNIS 17421). This program has sufficient funding for the proposed work in this resolution. Funding is provided by GO borrowing, Impact Fees, and Private Contributions/Donations.
