## **Fiscal Note**

In the adopted 2017 capital budget Engineering-Major Streets has budgeted \$8.26 million for the reconstruction of streets with substandard pavement and no curb and gutter within the Rural to Urban program (MUNIS 10204). The minor project for the South High Point Rd. at Velvet Leaf Drive project is budgeted with sufficient authority for the proposed work in this resolution (MUNIS 10422). Funding is provided by GO Borrowing.

The proposed resolution approves plan documents at a total estimated cost of \$200,000.
