**Fiscal Note**

In the adopted 2017 capital budget Engineering-Major Streets has budgeted \$3.3 million for the construction of a new roadway from Watts Road to South Point Road via the Watts.Road/Harvest Moon Lane capital project (MUNIS 11438). Funding is provided by GO Borrowing and associated Utility funding.

The proposed resolution approves plan documents at a total estimated cost of \$3,300,000 split amongst agencies as follows:

- Major Streets - \$1,677,500
- Stormwater Utility - \$621,500
- Sewer Utility - \$440,000
- Water Utility - \$561,000
