Fiscal Note

In the adopted 2017 capital budget Engineering-Major Streets has budgeted \$2,045,000 for the reconstruction of concrete pavement on the Capitol Square via the Capitol Square Pavement Replacement project (MUNIS 11429). Funding is provided by TIF proceeds from TID 32 and funding from the associated Utilities for those project components.

The proposed resolution awards the contract at a total estimated cost of \$2,504,140.
