In the adopted 2017 capital budget Engineering Major Streets has budgeted for the John Wall Drive construction at an estimated cost of \$2.55 million (MUNIS #11461). The proposed resolution approves plan documents at an estimated cost of \$2,283,000. This project is fully funded by assessments.
