## **Fiscal Note**

In the adopted 2017 Capital Budget the Parks Division has budgeted \$1,240,000 to maintain and improve existing park playgrounds and accessibility improvements under the Playground/Accessibility Improvements program (MUNIS 17436). This program has sufficient funding for the proposed work in this resolution. Funding is provided by a combination of GO borrowing, Impact Fees, and Private Contribution/Donations.
