## **Title**

Repealing Sections 3.14(1) through (3) and 3.14(4)(k) through 3.14(11) of the Madison General Ordinances to update the Department of Transportation Department ordinance.

#### **Body**

DRAFTER'S ANALYSIS: This proposal repeals the non-Charter provisions of Section 3.14, MGO, the Department of Transportation ordinance. Companion ordinance, Legistar #46377, repeals the Charter subsections of the same ordinance. Legistar #46249 recreates Section. 3.14.

The Common Council of the City of Madison do hereby ordain as follows:

- 1. Subsections (1) through (3) and Subsections (4)(k) through (11) of Section 3.14 entitled "Department of Transportation" of the Madison General Ordinances are hereby repealed.
  - 2. This ordinance will become effective on January 1, 2018.
