Title

CHARTER ORDINANCE - Repealing Section 3.14(4)(a) through (j) of the Madison General Ordinances to restructure the Department of Transportation.

Body

DRAFTER'S ANALYSIS: This proposal repeals the Charter Ordinances provisions of Section 3.14, MGO, the Department of Transportation ordinance. Companion ordinance, Legistar #46376, repeals the remainder of the same ordinance. Legistar #46249 recreates Section. 3.14.

A separate ordinance is needed to repeal Charter ordinances per Wis. Stat. § 66.0101.

The Common Council of the City of Madison do hereby ordain as follows:

- 1. Subdivision (a) through (j) of Subsection (4) entitled "Transit and Parking Commission" of Section 3.14 entitled "Department of Transportation" of the Madison General Ordinances are hereby repealed.
 - 2. This charter ordinance will become effective on January 1, 2018.
- 3. This is a charter ordinace and is effective 60 days after passage, subject to the referendum requirement of sec. 66.101(5), Wis. Stats.
