### Fiscal Note

The proposed resolution authorizes \$388,400 for miscellaneous improvements at the Overture Center Garage. The Overture Center Garage Elevator project (Munis #10403) has \$284,720 of available expenditure authority funded by Parking Utility reserves. A resolution (Legistar 46332) increasing the authority by \$115,000 funded by reserves was adopted by the Board of Estimates on March 13, 2017 and will go before the Council on March 21, 2017. If Legistar file 46632 is adopted by Council, funding will be available in the project for this contract.
