In the adopted 2017 Capital Budget the Water Utility has budgeted \$5.5 million for the construction of Unit Well 31 located on Tradewinds Parkway on the City's southeast side (MUNIS 10434). Construction began in 2015 and available funding within the project is sufficient for the contract costs in this proposed resolution. Funding is provided by revenue bonds.
