Fiscal Note

The proposed resolution authorizes \$70,460 for construction of the Darwin Road - Packers Avenue Traffic Signal. The Packers - Darwin Traffic Signal project (Munis #17449) has \$48,273 of available expenditure authority funded by GO borrowing. A resolution (Legistar 46372) increasing the authority by \$54,580 funded by special assessments was adopted by the Board of Estimates on March 13, 2017, and will go before the Council on March 21, 2017. If Legistar 46372 is adopted by Council, funding will be available in the project for the traffic signal construction.
