In the adopted 2017 capital budget the Water Utility has budgeted \$4.325 million for the renovations of the Water Utility Operations Center located at Paterson Street on the City's near east side (MUNIS 10442). The proposed resolution approves plan documents for the Water Utility Vehicle Storage Building at a an estimate cost of \$375,000. Funding for the project is provided by revenue bonds.
