## **Fiscal Note**

In the adopted 2017 capital budget the Stormwater Utility has budgeted \$1.275 million in the Citywide Flood Mitigation program to improve stormwater network performance at City locations that flood during large rainfall events. The proposed resolution approves plans for the Hughes Street storm relief and resurfacing project near the Villager shopping mall at a total estimated cost of \$1.56 million. Funding is provided by GO Borrowing and associated utility funding.
