Fiscal Note

In the adopted 2017 capital budget Engineering Major Streets has budgeted \$3,300,000 for the construction of a new roadway from Watts Road to South Point Road funded via assessments (MUNIS 11438). The proposed resolution awards the contract at an estimated cost of \$2,202,310.
