### Fiscal Note

In the adopted 2017 capital budget Engineering Major Streets has budgeted \$10.29 million for the resurfacing of existing streets via the Pavement Management capital program (MUNIS 10540). The proposed resolution approves plans for the Langdon Street resurfacing project at a total estimated cost of \$1,529,160. Funding is provided by GO Borrowing, special assessments, and associated utility funding.
