#### **Fiscal Note**

In the adopted 2017 capital budget, Engineering Major Streets has budgeted \$1,500,000 for the E. Johnson Undergrounding Utilities project (MUNIS 10241). Funding is provided by TID 32. The existing budget authority is sufficient for the estimated cost of the proposed agreement authorized by this resolution at a total estimated cost of \$1,400,000.
