### Fiscal Note

In the adopted 2017 capital budget Engineering Major-Streets has budgeted \$8.6 million for the reconstruction of streets with substandard pavement rating and no existing curb and gutter via the Reconstruction Streets capital program (MUNIS 10204). The minor project for Sunset Court is established with sufficient budget authority for the proposed contract (MUNIS 11431). Funding is provided by GO Borrowing and assessments. The proposed resolution awards the contract at an estimated cost of \$2,274,937.
