Fiscal Note

In the adopted 2017 capital budget Engineering-Pedestrian/Bicycle has budgeted \$2.3 million for the repair and replacement of defective sidewalks within aldermanic districts 15 and 17 via the Sidewalk Program (MUNIS 10148). The proposed resolution awards the contract for sidewalk sawcutting in District 15 at a total cost of \$69,190. Program funding is provided by Special Assessment and GO Borrowing.
