Fiscal Note

The 2017 adopted capital budget includes \$1,240,000 for Playground/Accessibility Improvements (Munis #17436) funded by GO Borrowing (\$645,000), Impact Fees (\$520,000), federal sources (\$40,000) and private contributions (\$35,000). The proposed resolution authorizes the Board of Public Works to advertise and receive bids for Playground Improvements Group 3, estimated at \$340,000. Funding is available.
