BE IT HEREBY RESOLVED:

- 1. That the plans and specifications for Local Road Traffic Calming & Arterial Pedestrian Enhancements-2016, be and are hereby approved.
- 2. That the Board of Public Works be and is hereby authorized to advertise and receive bids for the required public works contract.
- That the Mayor and City Clerk are hereby authorized to accept dedication of lands and/or easements from the Developer/Owner for public improvements located outside of the existing public fee title or easement rights-of-ways.
- 4. That the Mayor and City Clerk are hereby authorized to enter into an agreement with Don Miller Group to reimburse the City for the costs to install the mid-block pedestrian crossing on Tokay Blvd.
