The proposed resolution amends Traffic Engineering's 2017 Adopted Capital Budget by increasing authority for the McKee Road (CTH PD) - Muir Field Road - County Grove Drive Signal (Munis Project 10245) by \$15,922.55 funded by Special Assessments.

### **Title**

WHEREAS, the assessable funds required to pay for this project were not included in Traffic Engineering's 2017 Capital budget; and

WHEREAS, the Common Council of the City of Madison adopted a preliminary resolution, declaring its intention to exercise police powers and special assessment costs for installation of traffic signals at McKee Road (CTH PD) - Muir Field Road - Country Grove Drive and all other statutory requirements, pursuant to Section 66.0703(4), Wis. Statutes; and

WHEREAS, the Board of Public Works having reported on all the proceedings in relation to the installation of traffic signals at McKee Road (CTH PD) - Muir Field Road - Country Grove Drive in accordance with Section 66.0701 of the Wisconsin Statutes and having in all things duly conformed to the order of the Common Council in relation thereto, and the provisions of the Madison General Ordinances and the Wisconsin Statutes in such case made and provided, and the Common Council being fully advised;
