### **Fiscal Note**

The proposed resolution approves plan documents for the Corporate Drive Greenway Repair project on the City's east side. The Stormwater Utility has budgeted \$317,500 of borrowing and \$32,500 of Stormwater reserve funds for the Greenway Improvements capital program in 2017 (MUNIS 10312) which encompasses the planned project. The estimated cost of the project is \$345,600.


