**Fiscal Note**

The proposed resolution authorizes the recreation of position #760 from a Program Assistant 1(CG20, RG11) to a Program Assistant 2 (CG17, RG12) in the Information Technology Department. The cost of recreating the position for the remainder of 2017 is approximately \$1,675, including benefits. The 2017 costs will be funded through the management of salary savings. The projected annualized cost is \$3,335, including benefits.
