#### **Fiscal Note**

The proposed resolution approves plan documents for Crazylegs Plaza and Wingra Park entrance as part of the planned Monroe Street Reconstruction project in 2018 as proposed in the executive capital budget. The estimated cost of the improvements is \$250,000 which is sufficiently planned within the proposed 2018 project budget.
