Fiscal Note

The proposed resolution amends the 2017 Adopted Capital Budget authorizing transferring \$57,000 of existing TIF #32 proceeds from the East Johnson Undergrounding Utilities project (MUNIS 10241) to the West Mifflin Street Undergrounding project. The West Mifflin Undergrounding project is a new project that was not part of the 2017 Adopted Capital Budget.
