NOW, THEREFORE, BE IT RESOLVED

- 1. That said sanitary sewer, storm sewer, and street improvements (excluding bituminous surface pavement) be and are hereby accepted.
- 2. That said sanitary sewer improvements are hereby assigned to the Madison Sewer Utility for ownership and maintenance and that the attached Schedule "A" representing the actual cost of construction of these

3. That said storm sewer improvements are hereby assigned to the Madison Storm Water Utility for ownership and maintenance and that the attached Schedule "A" representing the actual cost of construction of these improvements shall be reflected in the Madison Storm Water Utility's "Utility Plant In Service".

Increase in Total Plant Value per Schedule "A" \$108,340.86.

- 4. That the street improvements, **excluding the bituminous pavement**, on the following streets be and are hereby accepted:
 - Milky Way from the N line of Lot 924 to the S line of Lot 990.
 - Caldera Street from Milky Way to the E line of Lot 846.
 - Saturn Drive from W line of Lot 929 to the E line of 880
 - · Aries Way from Milky Way to the E line of Outlot 42

The attached Schedule "A" representing the actual cost of construction of these improvements, which shall increase the street infrastructure value for Project No. 11480 \$264,804.02 for a useful life of 40 years.
