### Fiscal Note

The proposed resolution approves plans and specifications and authorizes the Board of Public Works to advertise and receive bids for 2018 Tennis and Basketball Court Resurfacings. The total estimated cost of the project is \$121,874.15. The Parks Division 2018 Capital Budget includes \$1,821,000 for Park Land Improvements (Munis project 17421) funded by GO Borrowing (\$1,082,000), Impact Fees (\$719,000), and Donations (\$20,000). Funding is available in this project.
