NOW, THEREFORE, BE IT RESOLVED that Metro Transit, on behalf of the City of Madison, is authorized to accept funding not to exceed \$10,000 from the Dudgeon Monroe Neighborhood Association in order to purchase and install approximately 6 benches to bus stops in the Dudgeon Monroe neighborhood;

BE IT FURTHER RESOLVED, that the 2018 Adopted Operating Budget of the Transit Utility is amended to

appropriate these funds from the Dudgeon Monroe Neighborhood Association.
