Fiscal Note

The proposed resolution amends the 2018 Stormwater Utility Capital Budget to accept the Dane County grant award of \$100,000 for the Wingra Park Screen Structure project within the Stormwater Quality System Improvements capital program. The 2018 adopted Capital Budget includes \$2.1 million for the program. The grant requires a 50% local match, or \$50,000; the match will be funded through existing appropriation in the program.

Title

Body

WHEREAS, The 2018 Storm Water Utility Capital Budget provides funding for construction of the Wingra Park Screen Structure project, estimated to cost \$210,000; and

WHEREAS, City Engineering has applied for and received a Dane County Urban Water Quality grant for up to \$100,000.00 through a fifty percent match; and

WHEREAS, City Engineering would like to proceed with this project;

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1) That the City of Madison, through City Engineering, is authorized to accept this grant from Dane County.
- 2) Be it further resolved that the City of Madison, through the City Engineer, is authorized to sign and submit the following: grant agreement, reimbursement claims, interim and final reports, and additional forms as required
- 3) Be it further resolved that the 2018 Stormwater Utility Capital Budget is hereby amended as follows:
