### Fiscal Note

The proposed resolution approves plans and specifications and authorizes the Board of Public Works to advertise and receive bids for the Elver Park Fully Accessible Playground project. The total estimated cost of the project is \$259,200. The Parks Division 2018 Capital Budget includes \$1,345,000 for Playground/Accessibility Improvements (Munis project 17436) funded by GO Borrowing (\$745,000), Impact Fees (\$565,000), and Donations (\$35,000). Funding is available in minor project Elver Accessible Playground (Munis project 17366) within the Playground/Accessibility Improvements project.

Contingency (8%): \$19,200; 17366-51-130:54250(98863)  
Total: \$259,200
