**Fiscal Note**

The proposed resolution approves plans and specifications and authorizes the Board of Public Works to advertise and receive bids for the Park Playground Improvements - Group 2 project. The total estimated cost of the project is \$405,000. The Parks Division 2018 Capital Budget includes \$1,345,000 for Playground/Accessibility Improvements (Munis project 17436) funded by GO Borrowing (\$745,000), Impact Fees (\$565,000), and Donations (\$35,000). Funding is available in the minor projects below within the Playground/Accessibility Improvements project.
