Fiscal Note

The proposed resolution approves the use of Safe Routes Grant funding in an estimated total cost of \$5,900 for installation of new sidewalk on Starker Avenue. In the adopted 2018 Capital Budget, Engineering-Bicycle and Pedestrian has budgeted \$150,000 for the Safe Routes Grants program (MUNIS 11112). This program pays 50% of a property owner's sidewalk assessment where new sidewalk is installed on eligible projects. Funding for this program is from GO borrowing.

The Common Council approved Plans, Specifications, And Schedule of Assessments for Starker Avenue Sidewalk Assessment District - 2018 on June 5, 2018, File ID 51505. Safe Routes Grants funding will be applied to all properties within the project limits with new sidewalk installation and reduce the amount due for assessments by 50 percent for the installation of new sidewalk.
