WHEREAS, the City of Madison Fire Department and the Madison community lost a valued member on April 1, 2018 with the line of duty death of Firefighter-Paramedic Richard Lance Garner Jr.; and,

WHEREAS, Firefighter-Paramedic Richard Lance Garner Jr. made the ultimate sacrifice after providing emergency services to the community of the City of Madison; and,

WHEREAS, Firefighter-Paramedic Richard Lance Garner Jr. was hired as a firefighter on the 24<sup>th</sup> of September, 2012 and appointed to Paramedic on the 6<sup>th</sup> of June, 2017; and,

WHEREAS, he was assigned to the City of Madison Fire Station No. 10 on Madison's north side, working diligently and tirelessly with his crew; and,

WHEREAS, Firefighter-Paramedic Richard Lance Garner Jr. was especially committed to leading and

mentoring the youth within the community; and,

WHEREAS, his sense of humor, kindness, and energy enriched those fortunate enough to know and work with him, or receive his care; and,

WHEREAS, Firefighter-Paramedic Richard Lance Garner Jr. served the City of Madison residents with diligence, bravery, integrity, and compassion,

NOW, THEREFORE BE IT RESOLVED that the City of Madison, Wisconsin, honors the memory of Richard Lance Garner Jr, mourns his death, and gratefully acknowledges his remarkable achievements, contributions, and service to the citizens of Madison; and,
