## **Fiscal Note**

The proposed resolution approves the plans and specifications and authorizes receiving bids for construction and installation of a launch for kayaks, canoes, and other non-motorized boats along Starkweather Creek. The Community Development Division will provide up to \$35,000 of federal Community Development Block Grant (CDBG) funds to Engineering for a boat launch and other eligible projects along Starkweather Creek. Engineering understands that use of these federal funds requires compliance with various HUD regulatory standards and mandates. Adopted RES-17-00851 (Legistar file 49065) authorized the use of up to \$120,000 of CDBG funds to implement neighborhood improvement projects that address objectives identified in the Darbo-Worthington-Starkweather Creek Neighborhood Plan.
