Fiscal Note

The proposed resolution approves plans and specifications and authorizes the Board of Public Works to advertise and receive bids for the Breese Stevens Field - Concession and Restroom Building (Munis project 17158). The Parks Division 2018 adopted capital budget includes \$475,000 funded by Impact Fees for the project. RES-18-00397 adopted on May 15, 2018, authorized an additional \$1,300,000 funded by GO Borrowing (\$650,000) and Impact Fees (\$650,000) for soccer related improvements at the field. The estimated cost of the bid is \$1,200,000. Budget authority is available in the project.

BE IT RESOLVED,

necessary and grant or accept dedication of lands and/or easements from/to the Developer/Owner for public improvements located outside of existing public fee title or easement right-of-ways.
