### Fiscal Note

The proposed resolution reclassifies Monona Terrace position #4234 from an Monona Terrace Technical Services Specialist 2 (CG16-RG15) to an IT Specialist 2 (CG18-RG8). The reclassification results in an annual increase of \$7,569 including both salary and benefits. In 2018, the Monona Terrace anticipates to absorb the increased cost of the reclassification with salary savings resulting from existing position vacancies.
