### **Fiscal Note**

The proposed resolution reclassifies Monona Terrace position #3597 from an IT Specialist 2 (CG18-RG8) to an IT Specialist 3 (CG18-RG10). The reclassification results in an annual increase of \$6,200 including both salary and benefits. In 2018, the Monona Terrace anticipates to absorb the increased cost of the reclassification with salary savings resulting from existing position vacancies.
