As stated in the Employee Agreement between the City of Madison and Thomas O. Heikkinen, the Water Utility General Manager's initial year's salary will be based on a total annualized rate of \$151,011 effective August 4th, 2018. The Water Utility's adopted 2018 operating budget includes sufficient funding for the cost of the position. Annual salary adjustments may be made during the term of agreement at the Mayor's discretion, subject to Common Council approval.
