## **Fiscal Note**

The proposed resolution reclassifies position #610 from a Word Processing Operator 2 (CG20, R08) to an Administrative Clerk 1 (CG20, R09) within DPCED Office of the Director and reallocates the incumbent to the reclassified position. The annualized cost of the proposed reclassification is approximately \$1,467, including benefits. The Office of the Director has an overall projected budget surplus of approximately \$24,000 for 2018.

Delete the classifications of Word Processing Operator 1 in CG20, R06 and Word Processing Operator 2 in CG20, R08. Recreate a Word Processing Operator 2 (CG20, R08, pos. #610) to an Administrative Clerk 1 (CG20, R09) and reallocate the incumbent to the new position in the DPCED Office of the Director budget.
