WHEREAS, Douglas A. Earl and Janet L. Hunerdosse (the "Owners") are the owners of the property located at 6210 Mineral Point Road (the "Property") and have requested the release of a public sanitary sewer easement located on said property and recorded with the Dane County Register of Deeds as Document No. 1068144 on March 11, 1963 (the "Easement"); and

WHEREAS, said release will allow the construction of a trash enclosure on said property as required by Zoning; and

WHEREAS, City Engineering staff has reviewed and recommends the release of said Easement.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and City Clerk are hereby authorized to execute a Release of Public Sanitary Sewer Easement for the land described as follows:

The West 60.71 feet of the North 15 feet of said Lot 2, Block 1, Faircrest, Island - Lane Addition.
