WHEREAS, Rethke Washington, LLC, has satisfactorily completed the installation of storm sewer, sidewalk, and curb and gutter improvements by private contract, in accordance with the City of Madison Standard Specifications for Public Works Construction, at: 707-709 Rethke Avenue.

#### NOW, THEREFORE, BE IT RESOLVED

- 1. That said storm sewer, sidewalk, and curb and gutter improvements be and are hereby accepted.
- 2. That said storm sewer improvements are hereby assigned to the Madison Storm Water Utility for ownership and maintenance and that the attached Schedule "A" representing the actual cost of construction of these improvements shall be reflected in the Madison Storm Water Utility's "Utility Plant In Service".

Increase in Total Plant Value per Schedule "A" \$5,774.51.
