### Fiscal Note

The proposed resolution approves plan documents to receive bids for the demolition of Unit Well #3 at North First Street in coordination with the planned street reconstruction project at East Johnson Street (MUNIS 10287) in 2019; the cost of the demolition is estimated to be \$120,000. Funding for this demolition work is included within the Major Streets adopted 2018 capital budget for the initial phase of of the street reconstruction project from Baldwin Street to 1<sup>st</sup> Street. The Johnson Street reconstruction project is estimated to cost a total of \$6.245 million with approximately \$2.6 million being from Federal funding sources and the remainder funded by GO Borrowing, special assessments, and applicable utilities.
