#### **Fiscal Note**

Annual rent payable during the first five lease years shall be in the amount of \$1,000 and shall be deposited into the General Fund (Acct. No. 110010-43875-0000). Rent shall be subject to a 10% increase every five years beginning on the fifth anniversary of the air space lease.

#### **Title**

Granting an air space lease to Meriter Hospital Inc. to accommodate the existing skywalk connecting the two properties located at 202 South Park Street and 36 South Brooks Street.

### **Body**

DRAFTER'S ANALYSIS: This ordinance is a companion to Legistar File # 52986 for the lease of subterranean space and airspace.

The Common Council of the City of Madison do hereby ordain as follows:

A lease is hereby granted to Meriter Hospital Inc. for air space described in attached Exhibit A for an enclosed pedestrian skywalk. The lease is for a term of 98 years and is subject to the terms and conditions in a certain Air Space Lease between the City of Madison and Meriter Hospital, Inc.
