DRAFTER'S ANALYSIS: This ordinance updates the Madison General Ordinances through June 15, 2018. In lieu of referring this ordinance to the subsequent Common Council meeting, we are requesting the Common Council adopt this revision ordinance under suspension of the rules. This ordinance includes three revisions because the transition to the new Municode on line delayed the City Attorney's ability to file the revisions at the usual time.

The Common Council of the City of Madison do hereby ordain as follows:

All of Republication 2017 and all of Revisions Nos. 1, 2, and 3 of the Madison General Ordinances, as of June 15, 2018, incorporating the changes made by Ordinance Numbers ORD-17-00062 through ORD-17-00128 and Ordinance Numbers ORD-18-00001 through ORD-18-00060 are hereby adopted in its entirety and Volumes I, II, III and IV as revised through June 15, 2018 be confirmed in all respects.

Republication 2017 and Revisions Nos. 1, 2, and 3 are published in pamphlet form by direction of the Common Council of the City of Madison, in accordance with Wis. Stat. § 66.0103.
