WHEREAS, MMSD owns and maintains a contained and lined drying bed facility, located at 1610 Moorland Road, and

WHEREAS, the City of Madison does not have a City maintained drying bed facility, and

WHEREAS, The City conducts certain dredging projects and/or contracts with outside service providers for certain dredging projects including but not limited to the dredging of ponds, greenways, and lakes, which periodically produce dredge material that requires proper dewatering prior to disposal of this material, and

WHERAS, The City desires to use the Drying Bed for dewatering and/or temporary storage of Dredge Materials.

WHERAS, The City wishes to obtain MMSD's authorization to use the Drying Bed for such dewatering and

temporary storage, on all the terms and conditions set forth in this Agreement.

WHERAS, MMSD wishes to accommodate the City's request for authorization to use the Drying Bed for the purposes described in this Agreement, pursuant to the terms and conditions set forth in this Agreement.
