As stated in the Employee Agreement between the City of Madison and Yang Tao, the City Traffic Engineer's initial year's salary will be based on a total annualized rate of \$140,000 effective October 7, 2018. The Traffic Engineering's adopted 2018 operating budget includes sufficient funding for the cost of the position. Annual salary adjustments may be made during the term of agreement at the Mayor's discretion, subject to Common Council approval.

WHEREAS, Mayor Soglin has appointed Yang Tao to the position of City Traffic Engineer and has recommended to the Common Council that his appointment be confirmed; and

WHEREAS, the parties have reached an accord on the terms and conditions of an Employment Agreement between the City and Mr. Tao,

NOW THEREFORE, be resolved that Mr. Tao's appointment to the position of City Traffic Engineer is hereby confirmed, and the Mayor and the City Clerk's office are authorized to execute an Employment Agreement between the City and Mr. Tao.
