The proposed resolution approves plans and specifications and authorizes the Board of Public Works to advertise and receive bids for the Pinney Library Tenant Improvement Project. The total estimated cost of the project is \$4,800,000. Funding is available in the Relocate Pinney Neighborhood Library project (Munis #10002).

Title

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for the Pinney Library. (15th AD)

Body

The Capital Budget includes funding for the Pinney Library Tenant Improvement Project. The Project funds the comprehensive interior improvement of an unfinished condominium unit (i.e. architecture, mechanical, electrical/lighting, plumbing, fire protection, IT + AV) at Royster Commons Mixed Use development located at 516 Cottage Grove Road, with the goal of providing an improved Library environment for staff and customers.

This resolution approves the plans and specifications for the project, authorizes the Board of Public Works to advertise for and receive bids for the project, authorizes execution of any lease or easement documents necessary to accomplish the project and authorizes the acquisition of materials and services required to successfully complete the project.
