## **Fiscal Note**

The proposed resolution authorizes the award of Public Works Contract No. 8386, Forest Hill Cemetery Improvements 2019. The total estimated cost of the project is \$659,000. A companion resolution (Legistar 54949) was introduced on March 5, 2019, to authorize the transfer of \$84,000 GO Borrowing from the Beach and Shoreline program to the Forest Hill Cemetery Improvements project (Munis 17166) for this contract. If the resolution is approved, funding will be sufficient for the contract.
